The fees imposed on the Club are a hefty 7%, but there's no question that on-line renewals/applications are easy for both the Club and our members. Either way dues are paid, the fact that my husband Patrick is the SJC Treasurer makes for efficiency in the communications that allow accurate record keeping.

Members received a reminder from Mary Snyder of our annual due's renewal, beginning in December and continuing into January. Please remember annual renewal dues are due by April 1st. I want to thank everyone who has already renewed, and ask everyone else to renew as soon as practical. We aways take renewal checks at the annual event planning lunch in January.

While I'm no longer the President of the Sacramento Jaguar Club, I have by now had plenty of time and opportunities to acquaint myself with the important role the Membership VP holds within our club and am confident I can discharge my duties to the benefit of the Club, my fellow SJC officers, and our members.



MEET A MEMBER

Dick and Carol Cowan

Twin Jaguars—fifty years and two thousand miles apart.

Dick and Carol Cowan met locally at San Juan High School, but their first home together as a married couple was Ithaca, New York, where Dick was still a civil engineering undergrad student at Cornell University and Carol worked on campus to support them. One Sunday in April of 1968, while taking a drive around the countryside, they passed through Watkins Glen, New York, then home of the US Grand Prix racecourse. They spotted in the showroom window of a car dealership a gorgeous 1968 Jaguar XKE Roadster in Carmen Red. It was love at first sight for both Carol and Dick—they wanted that car! The middle-aged salesman patiently took the car loan credit information from them—mileage of the '66 VW they would trade in, how much they earned with Carol's full-time job and Dick's two part time jobs, and credit history (none). When the salesman finished, he pushed his chair back and said, "Kids, I'll turn this paperwork in, but I don't think it's going to work." Then, two days later, Carol intercepted Dick walking on campus between his classes. "The car dealer called, our loan is approved, we got the car!"

Over the next decades, Dick and Carol had other fun cars: A '67 Ferrari 330 GT, a '52 MGTD, a '60 Porsche 356B Cabriolet, an '83 Maserati Biturbo, and a '72 Fiat 500. Dick tried but failed to keep track of their Jaguar. Until June of 2021. For the hundredth time or so. Dick keyed the Jag's serial number, 1E16681, into the web browser. A car with that number in its VIN was registered in Iowa and for \$2.50, the Iowa public information would be delivered. Dick made a phone call to Iowa and left a lengthy message. A few days later, a very cautious man returned the call and shared that he had purchased the Jag from a dealer in Missouri, and that it had once been registered in Montana. He had no knowledge of Watkins Glen or Sacramento. He has a great mechanic, and "his" Jag looks and runs great. The new owner sent some current photos and Dick mailed some original purchase paperwork to reunite with the Jag.

But the new owner was sadly not interested in selling "his" Jag. So, after succeeding in the decades-long search, Dick wanted a replacement Jaguar, the next best things. So, the search was on. Watching sales and auctions on eBay and Bring a Trailer, Dick found a 1968 XKE Roadster with a dealer in San Carlos, California, a few hours' drive from Sacramento. It was even Carmen Red. After a visit and test drive, a price was agreed upon. The car looked good cosmetically, but its mechanical history was not known.



The British have an expression, "the car needs sorting out." And the sorting out began immediately, with a ride back to Sacramento on a flatbed after brake failure. Other flatbed rides home led to a succession of improvements: new tires, new fuel tank, fuel pump, clutch, and alternator. Dick and Carol joined the Sacramento Jaguar Club and got some good local advice from fellow members. Some of the Jaguar events were the occasions of "sorting out" problems. Currently the Jag is running great and looks great, too.

Would getting 1E16681 back to Sacramento be a better end to this saga? Sure. But, knowing it is safe and well cared for means a lot. And in the meantime, its twin sister, 1E18343, gives a lot of smiles with the miles.
